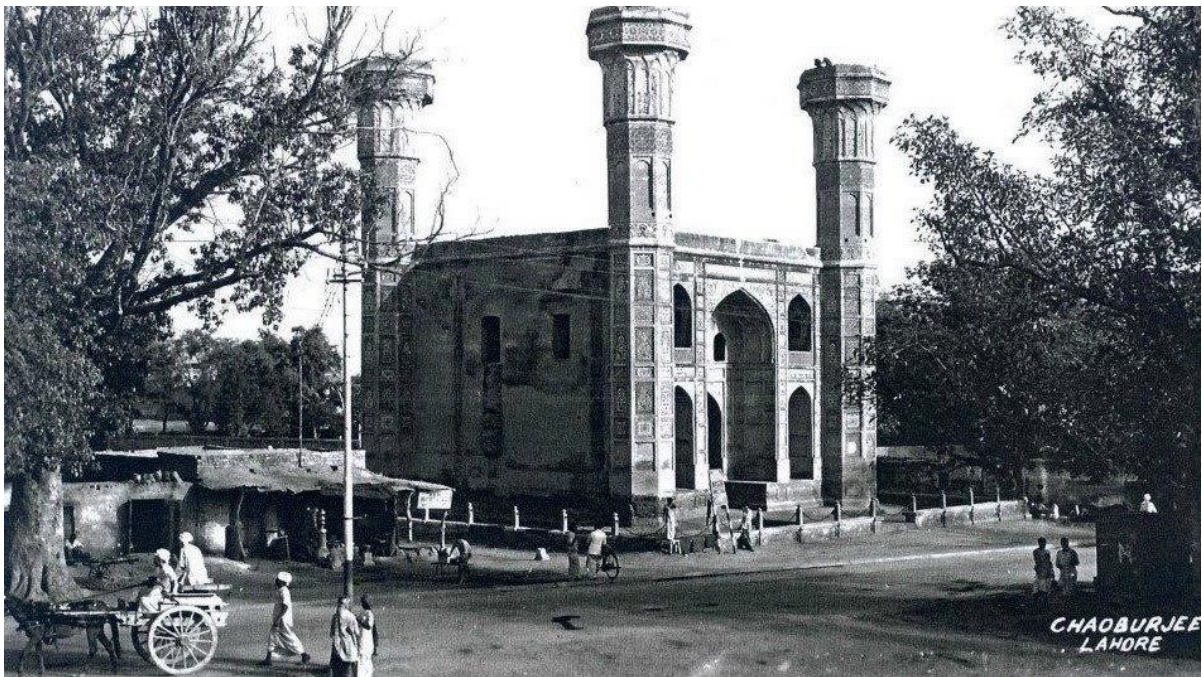
## **INTRODUCTION**

Article “32” of police Order 2002 made the provision of the Annual Policing Plan mandatory for every head of the District Police, in which he put forward details of objectives and achievement and set targets to be achieved for good performance of the police

The police system in Pakistan is always criticized on account of inefficiency, lack of public trust and insufficient mechanism to comply with international policing standards. A number of attempts by previous governments have been made to reform the police system but mostly influenced by political decisions. A Strategic Development Plan to revamp the police system of Capital City Police, Lahore has been framed for organizational growth and professional development keeping in view the existing challenges and future needs. Strategic Planning is an organization’s process of defining its strategy or direction and making decisions on allocation of resources to pursue its goals for at least three to five years. The proposals framed in the given strategic framework are based on empirical evidence collected through data from various police units. The ultimate objective of proposed strategic plan is to devise a strategy to develop Capital City Police of Lahore as per international Standards of policing.

The proposed plan will not only fulfill the gaps in legal regimes for effective law enforcement but also transform the organizational structure as well as culture for more efficiency and effectiveness. It will also strengthen the mechanism of Internal & External Accountability of Police through enforcement of proposed procedures with the implementation of public oversight structure.

## HISTORY OF LAHORE



### Mughal Era:

The geographical boundaries of the place now called 'Lahore' have been the traditional capital of Punjab for a thousand years. It had been the cultural centre of Northern India extending from Peshawar to New Delhi. It holds this pre-eminent position in Pakistan as well. Lahore is the city of poets, artists and the centre of film industry. It has the largest number of educational institutions in the country and some of the finest gardens in the continent.

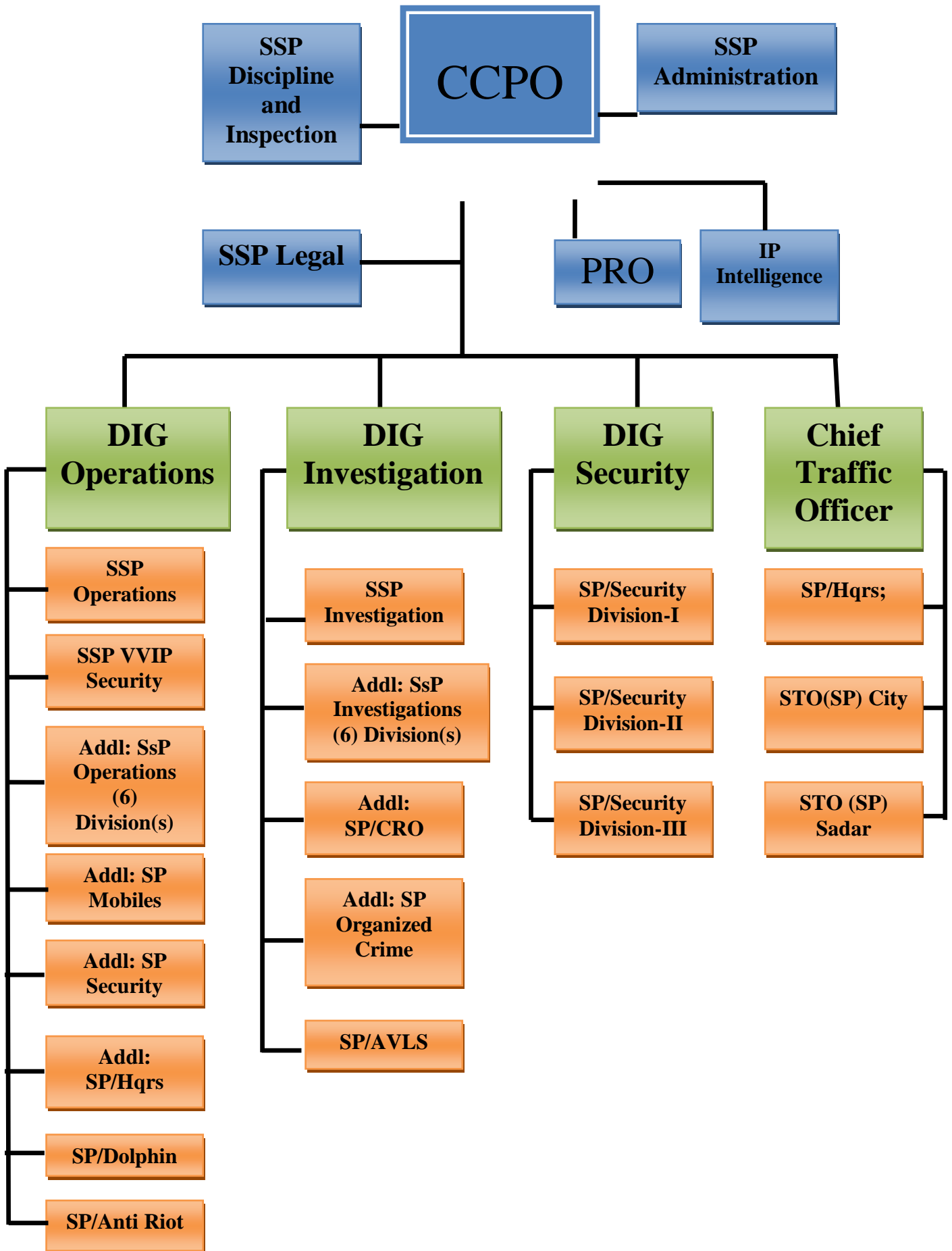
### Geography.

Lahore is the capital of Punjab Province. It lies in the north near the Indian border, some 650 miles (1,050 km) northeast of Karachi. Lahore, the nation's second largest city, is a major center of transportation, manufacturing, and commerce. Culturally, it is Pakistan's leading city, mainly because of its long history, Islamic tradition, and outstanding buildings and institutions. Among them are the great Badshahi Mosque, Shalimar Gardens, and Punjab University. Lahore, an ancient city, first became prominent during the 11th and 12th centuries as capital of two Muslim kingdoms that originated in Afghanistan. Thereafter, for almost 400 years, it was devastated repeatedly by invaders, mainly Mongols from the north. A golden age came with the Moguls during the 16th and 17th centuries, when magnificent mosques,

gardens, tombs, and palaces were built. Control passed to the Sikhs in 1767 and to the British in 1849. With India's partition in 1947, Lahore became part of Pakistan.

It is located near the Ravi River and Wagah, close to the Pakistan-India border. According to legend, Lahore was founded by Lav, son of Lord Rama of the Hindu epic Ramayana. Punjabi and Urdu are the native languages of the province and the most widely-spoken language in Lahore and rural areas. Urdu and English, however, are becoming more popular with younger generations since they are officially supported, whereas Punjabi has no official patronage. Many people of Lahore who speak Punjabi are known as Lahori Punjabi due to their use of a mixture of Punjabi and colloquial Urdu. Lahore is bounded on the north and west by the Sheikhpura District, on the east by Wagah, and on the south by Kasur District. The Ravi River flows on the northern side of Lahore. Lahore city covers a total land area of 404 km<sup>2</sup> and is still growing.

Earlier the Lahore comprised only 6 towns. However, in 2001 due to revision of administrative setup it was tagged as Capital City District, further 3 new towns were added. So, the total town size rose from 6 to 9. Under each town there are respective U.C's (Union Councils) and each union council consist of numerous areas. Currently total Number of UC Seats are 274.

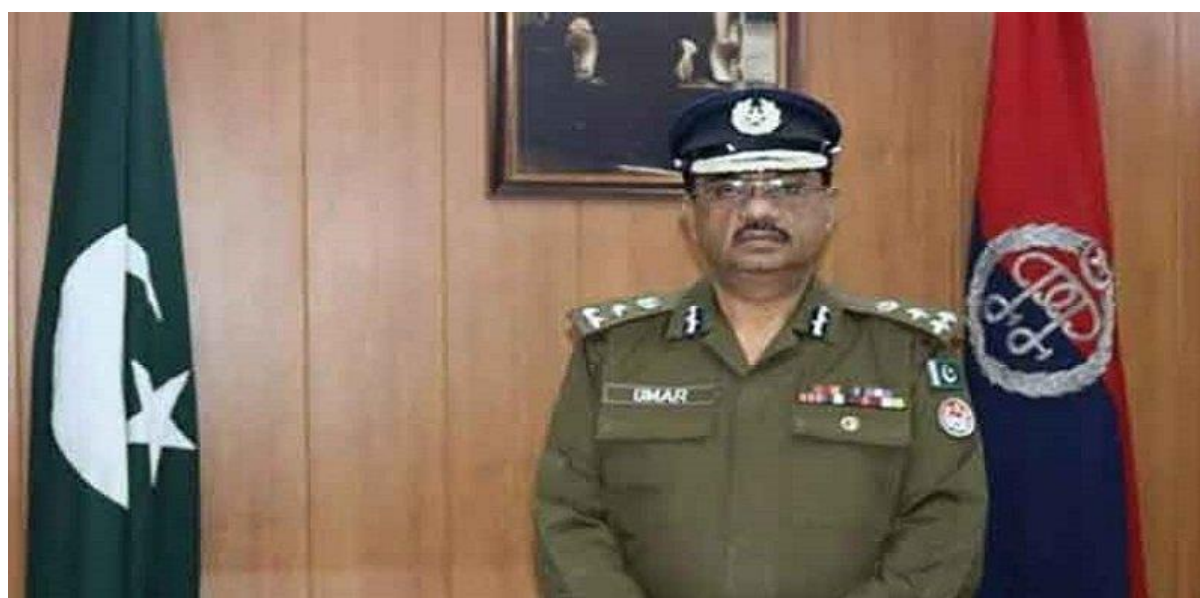
