## EXPLANATORY NOTE

Census of Manufacturing Industries (CMI) is conducted as a regular feature through joint efforts of Federal Bureau of Statistics, Provincial Directorate of Industries and Provincial Bureau of Statistics with following distribution of job.

### SCOPE & COVERAGE

Census of Manufacturing Industries (CMI) is conducted under Industrial Statistics Act, 1942 and covers those establishments registered under factories Act, 1934 and engage in manufacturing activities for whole or part of the year. However the defense & government workshops through engaged in the manufacturing activities and registered under the factories act are excluded and termed as Non-CMI.

### PLANNING & EXECUTION OF CENSUS

Census of manufacturing Industries (CMI) 2005-06 is the product of Joint efforts of Federal Bureau of Statistics, Provincial Directorate of Industries and Provincial Bureau of Statistics. The work has been carried on according to the following arrangements.

#### I) Federal Bureau of Statistics.

Federal Bureau of Statistics is responsible for Planning, Preparation of questionnaire and tabulation plan in collaboration with Provincial Bureau of Statistics and finally preparation and publication of CMI tables on national level.

#### II) Provincial Directorate of Industries.

Provincial Directorate of Industries being a Statistical Authority is responsible for :-

- i) Notification of the Census of Manufacturing Industries in the government gazette.
- ii) Printing & mailing of questionnaire, the questionnaires are mailed out on the basis of list of factories as available with provincial Directorate of Labour.
- iii) Collection of filled CMI returns.
- iv) Preliminary editing of CMI returns.
- v) Maintenance of up to date mailing list of the manufacturing establishments with collaboration of the Directorate of Labour.

III. Provincial Bureau of Statistics.

Provincial Bureau of Statistics is responsible for the following job:-

- i) Scrutiny of the filled CMI questionnaire received from the Directorate of Industries.
- ii) Classification of the questionnaire on the basis of major manufacturing activity of the establishment.
- iii) Editing & coding of the filled CMI questionnaire.
- iv) Processing of CMI data and supplying the summary tables of the province to the Federal Bureau of Statistics as per approved tabulation plan.
- v) Estimation of CMI data in respect of non-response cases.

COLLECTION OF RETURN AND NON-RESPONSE.

CMI questionnaire are issued to the factories as per list of manufacturing establishments (frame of the census maintained by the Provincial Directorate of Industries). The CMI is conducted through mail enquiry supplemented by field visits. The collection is done by the agency appointed for the purpose under the Industrial Statistics Act, 1942. The Act empowers a provincial government to appoint an officer to collect the data in connection with the census. In Sindh province. The Directorate of Industries is the Statistical Authority under this Act, who collects the questionnaires from the registered manufacturing establishments and passes on these returns to Sindh Bureau of Statistics. The position of collection & non-response is given in table No.1.

MANUFACTURING ACTIVITY.

Manufacturing activity is defined as the mechanical or chemical transformation of inorganic or organic substances into new products whether the work is performed by power driven machines or by hand or where it is done in factory or in the workers house. The assembly of component parts of manufactured products is also considered as manufacturing.

LIMITATIONS OF CENSUS OF MANUFACTURING INDUSTRIES (CMI).

1. The mailing list used for the Census of Manufacturing Industries may be up to date.
2. The reported data suffers from the errors, deficiencies, inconsistencies that were corrected on the basis of available supplementary information and past trends.
3. The census results become available with a time lag of about three years, which is chiefly due to the time taken in collection of filled questionnaires.
4. The size and nature of non-response varies from year to year.

DEFINATION OF IMPORTANT TERMS USED IN THE PUBLICATION.

Definitions of important terms used in the publication are given below:-

- i) Fixed Assets: Consist of land and building, plant and machinery and other fixed assets which are expected to have a productive life of more than one year and are in use by the establishment for the manufacturing activity. The details about fixed assets are given below:-
  - a) Land: Including all the land owned by the factory at its location in addition to land on which factory building are situated.
  - b) Buildings: Means all the buildings at factory location used directly or indirectly for manufacturing process. Godowns and buildings used for welfare purpose of workers such as residence, canteens are also included.
  - c) Plant and Machinery: Includes machines, hand tools and other mechanical equipment used in the manufacturing process.
  - d) Transport Equipment: Includes motor vehicles, car, wagons etc.
  - e) Furniture and Fixtures mean all fixed assets not included in the categories listed above.
  - f) Other Fixed Assets: mean all furniture and fixtures such as air conditions, electric fans, electric heaters, refrigerators etc.
  - g) Addition & Altration: Additions and alterations made during the year consist of purchases (both Pakistan made and imported) and assets made for own use minus sales losses of assets during the year.
  - h) Deprecation: means allocation of operating expenses of the cost of the physical assets over the accounting year. The provisions is made to cover the wear and tear of all fixed assets maintained in the books.
  - i) Books value at the end of the accounting year: It is equal to the book value at the beginning of the accounting year less depreciation charged for the year.
  - j) Stock: Including values of raw materials, spare parts, packing material, fuels and other input material (like chemicals and dyes lubricants etc) semi finished products and by products and goods to be sold in the same condition as purchased at the beginning / end of the year.
  - k) Average daily person: This includes employees, working proprietors, unpaid family workers and home workers.
  - l) Employees: Means all persons whether part time or full time who work in or for the establishment and receive pay in cash or in kind. Working properties, unpaid family workers and home workers are excluded. The categories of employees are given below:-
    - a) Production workers: Those who are engaged on work directly associated with production like manufacturing, assembling, packing, repairing etc work supervisors and persons engaged for repairs and maintenance are also included.

- b) Contract Labour: Those persons who are engaged through labour contractor or sub-contractor for manufacturing process.
- c) Non-Production Workers: Including administrative and professional employees, officers employees, drivers, watchmen, peons, sweepers etc.
- V) Employment Cost: Wages and salaries plus cash and non-cash benefits paid to the workers. Remuneration of the workers is given below:-
- a) Wages and salaries: Means payments made to employees as remunerations for their work. It includes dearness allowances and payment for leaves.
- b) Other Cash Payments:- Includes conveyance allowance, house rent allowance, compensation and other such allowances, bonus, employer's contribution towards social security scheme and provident fund and commission. Amount of gratuity and pension is excluded.
- c) Non Cash Benefits: Means goods and services provided to employees free of cost or at subsidized rates. These include rent free accommodation, medical & transport facilities, cheap/free consumer goods etc in term of money.
- VI) Industrial Cost: It consist cost of raw materials fuels and electricity consumed, payment for work done, payments for repairs and maintenance and cost of goods purchased for resale. Some of these components are defined below:-
- a) Fuels: Means firewood coal,coke,charcoal,oils,gas and other such items which are consumed generating heat & power.
- b) Raw Materials:- Means semi finished or raw materials, assembling parts etc which are physically reward incorporated in the products and by products made. Chemical, lubricants and packing materials, which are consumed in the production manufacturing goods (semi-finished and finished) on behalf of the establishment is included whereas raw material supplied by others for manufacturing goods on their behalf is excluded.
- c) Payments for work done:- Mean the amount paid to other establishments for the work done by them on the raw material supplied be the establishment. This also includes payment to home workers.
- VII) Value of Production:- Consist of the value of finished products and by products receipts for work done for others, receipts for repairs and maintenance, value of sale of semi-finished products and by products ,wastes and used goods, value of electricity sold,value of sales for goods purchased for resale, the net increase in the value of work in the process and the value of fixed assets produced by the establishment for its own use. Valuation is made at ex-factory prices, which include indirect taxes and exclude transport cost outside the factory gate. Some components of value of production are defined below:-



(V)

- a) Products and by-product:- Includes only final products and by-products of the establishment and exclude intermediate products and by-product used as raw material for final products o the establishment. Products and by-products manufactured by others on behalf of the establishment for which raw material was supplied are included, where as products and by-products manufacturing on behalf of others from the raw material supplied by them are excluded.
- b) Receipts for work done for others:- Means the amount charged for customers for the work done for them on their raw material, Repairs and maintenance work & services performed for others are also included.
- VIII) Census Value Added:- Value of production (vii above) minus industrial cost(vi-above).
- ix) Non-Industrial Cost:- It consist of cost of payment for transport, insurance payment, copy rights/royalties, postage, telegraph & telephone charges, printing and stationary cost, legal and professional expenses, advertising & selling expenses, traveling expenses and other such expenses incurred by the establishment.
- x) Non Industrial Receipts:- It includes receipts for transport services, receipts for storage and warehouse and other such receipts.
- XI) Net Non-Industrial Cost:- means non-industrial cost(ix above) minus non-industrial receipt(x above).( ix-x=xi )
- XII) Contribution to GDP:- Equal census value added (viii above) minus non-industrial cost (ix above). This value is at market price (viii-ix=xii.)

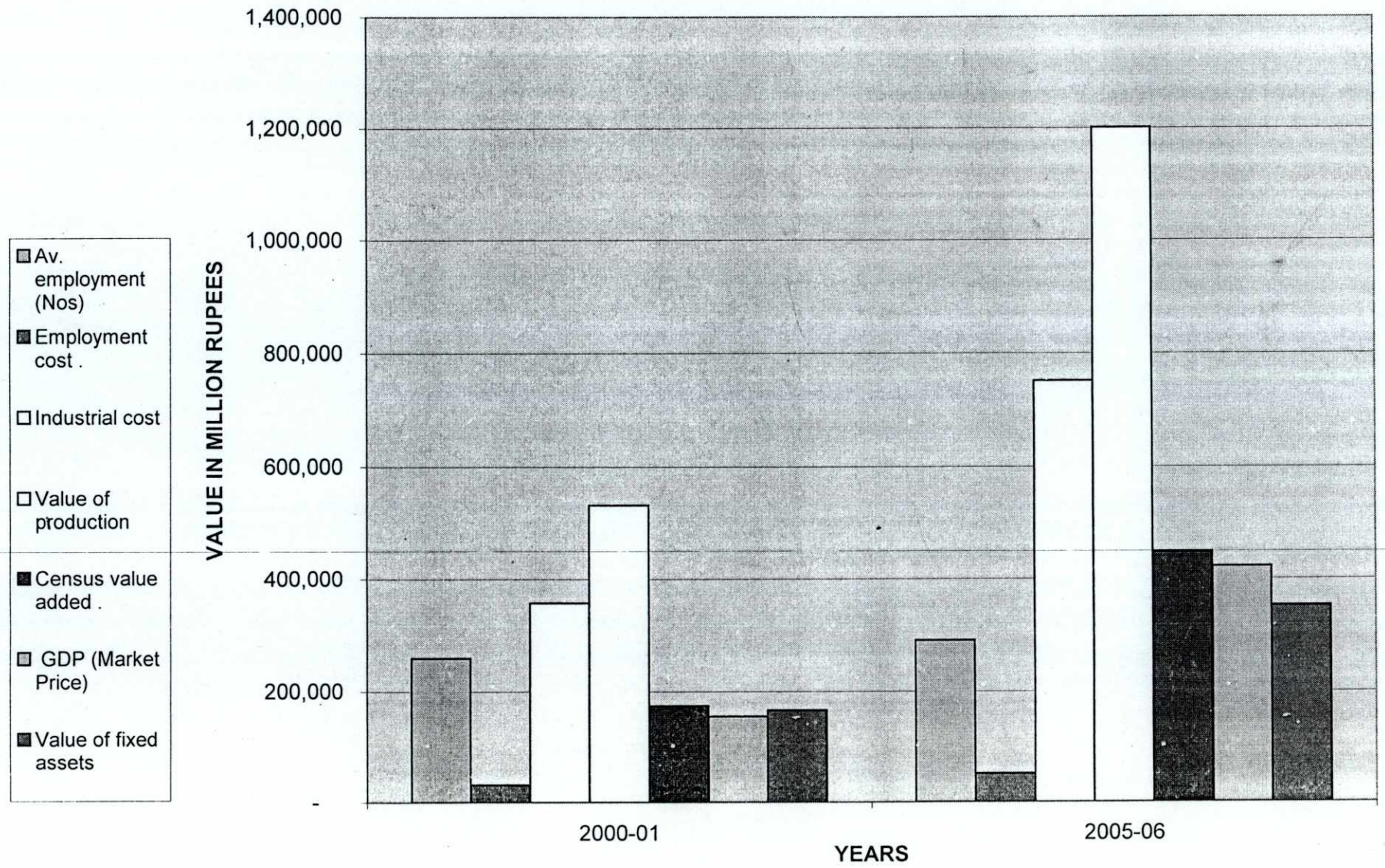

COMPARATIVE DATA OF IMPORTANT VARIABLES OF CMI 2000-01 AND 2005-06



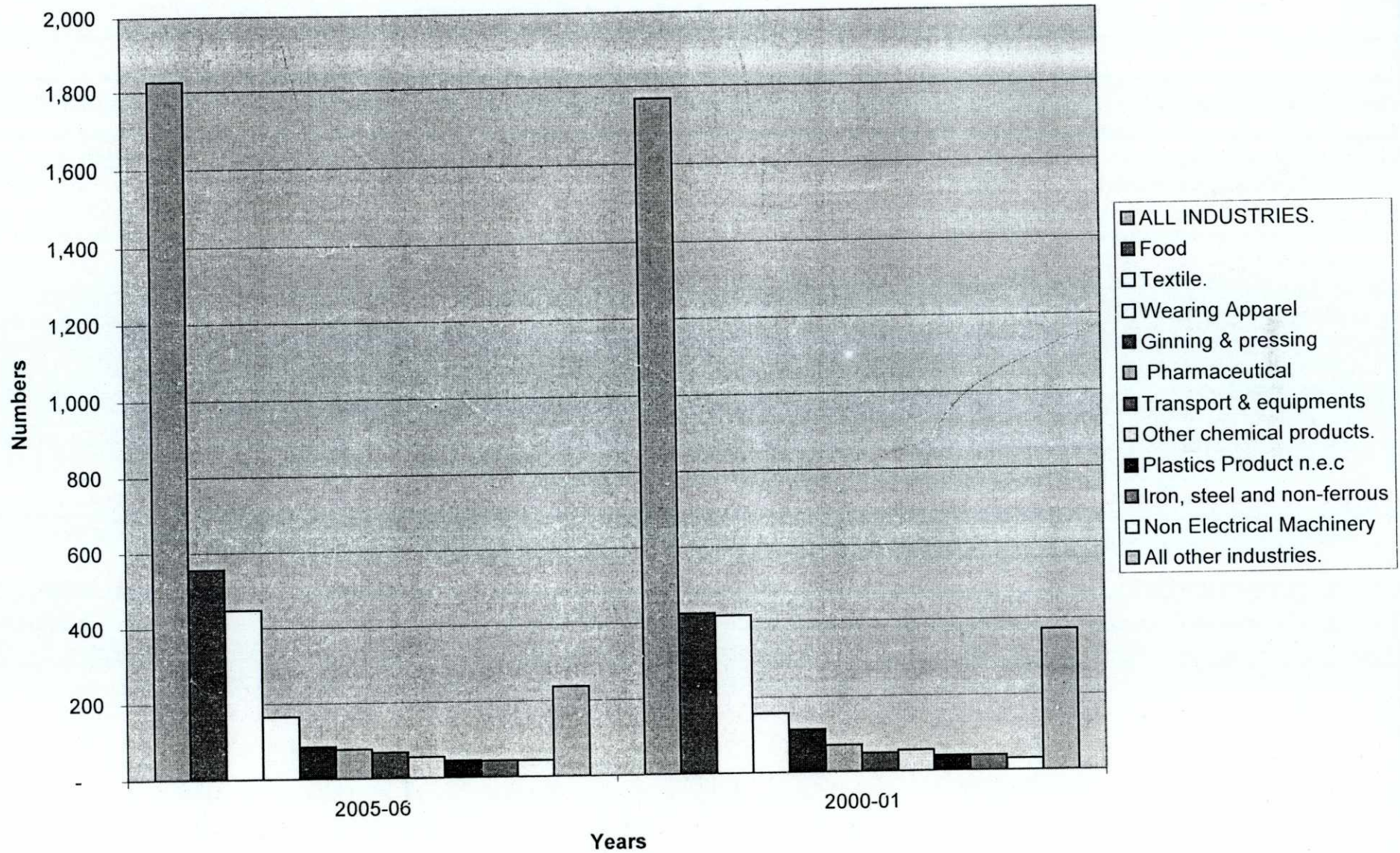

## 2 NUMBER OF REPORTING ESTABLISHMENTS

The total number of reporting establishments in 2005-06 is 1825 as against 1768 in 2000-01 showing an increase of 0.64% per annum. The maximum number of establishments fall in the food manufacturing where their number is 556 showing an increase of 6.23% per annum. The second major group is textile where the number units are 447 as against 417 in 2000-01. The third major group is wearing apparel where the number of units are 165 as against 156 in 2000-01. Following table depicts in descending order the position of number of reporting establishments for the first 10 leading industry major groups in Sindh.

No. of Establishments Reported in CMI 2005-06 & 2000-01



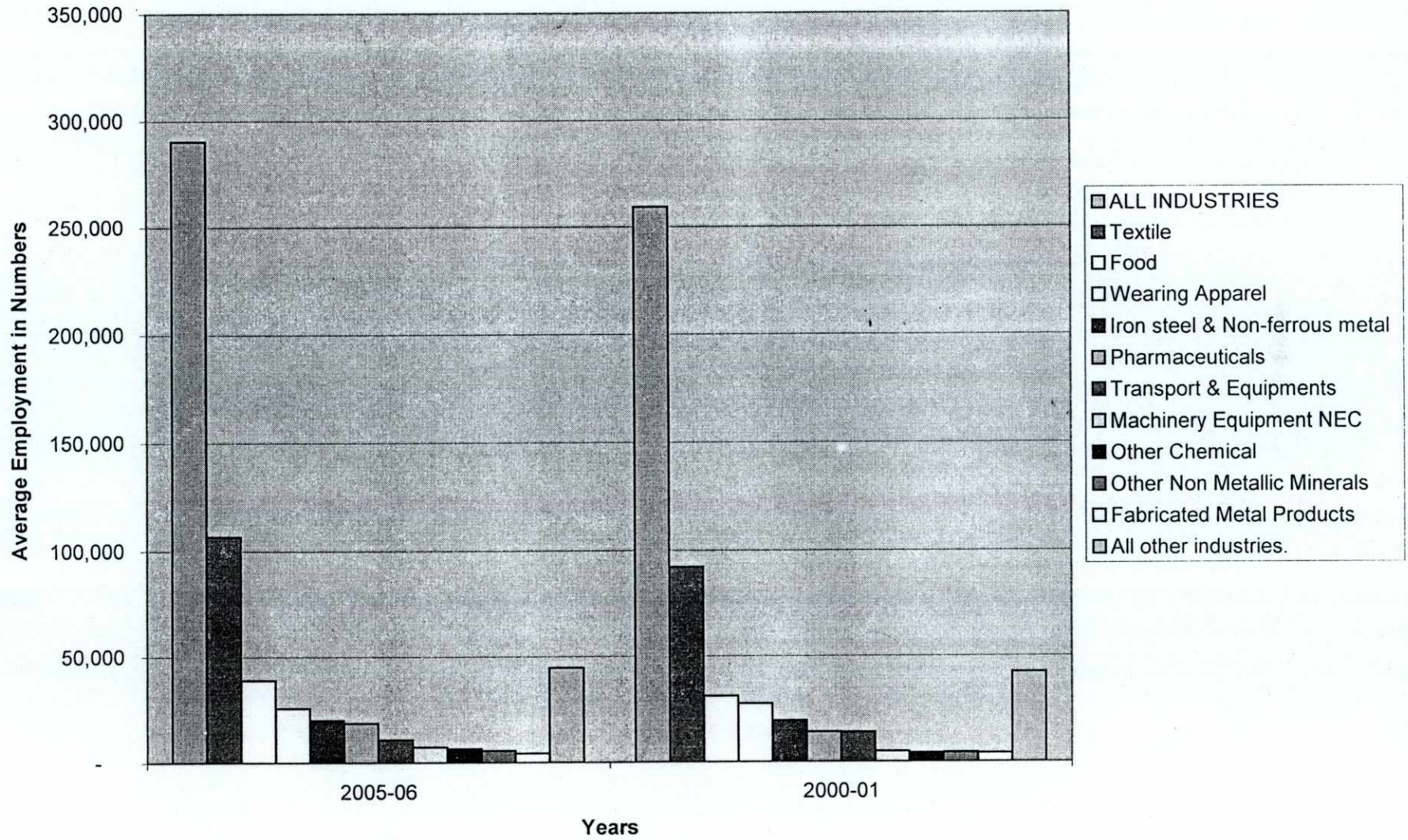

### 3 EMPLOYMENT.

The total reported employment during 2005-06 is 290,376 persons showing an annual increase of 2.40% over 2000-01 which stood at total of 259,267 persons. The largest number of persons are engaged in textile industries which is 106,761 persons. The second is Food Manufacturing which employed 39,015 and wearing apparel (except footwear) ranked the 3rd employing 25,746 persons. The number of persons engaged by the 1st 10 leading industries major groups during the year 2005-06 in descending order alongwith the comparative position for the year 2000-01 is given below:-

Comparative Picture Of Average Employment For The Years 2005-06 & 2000-01



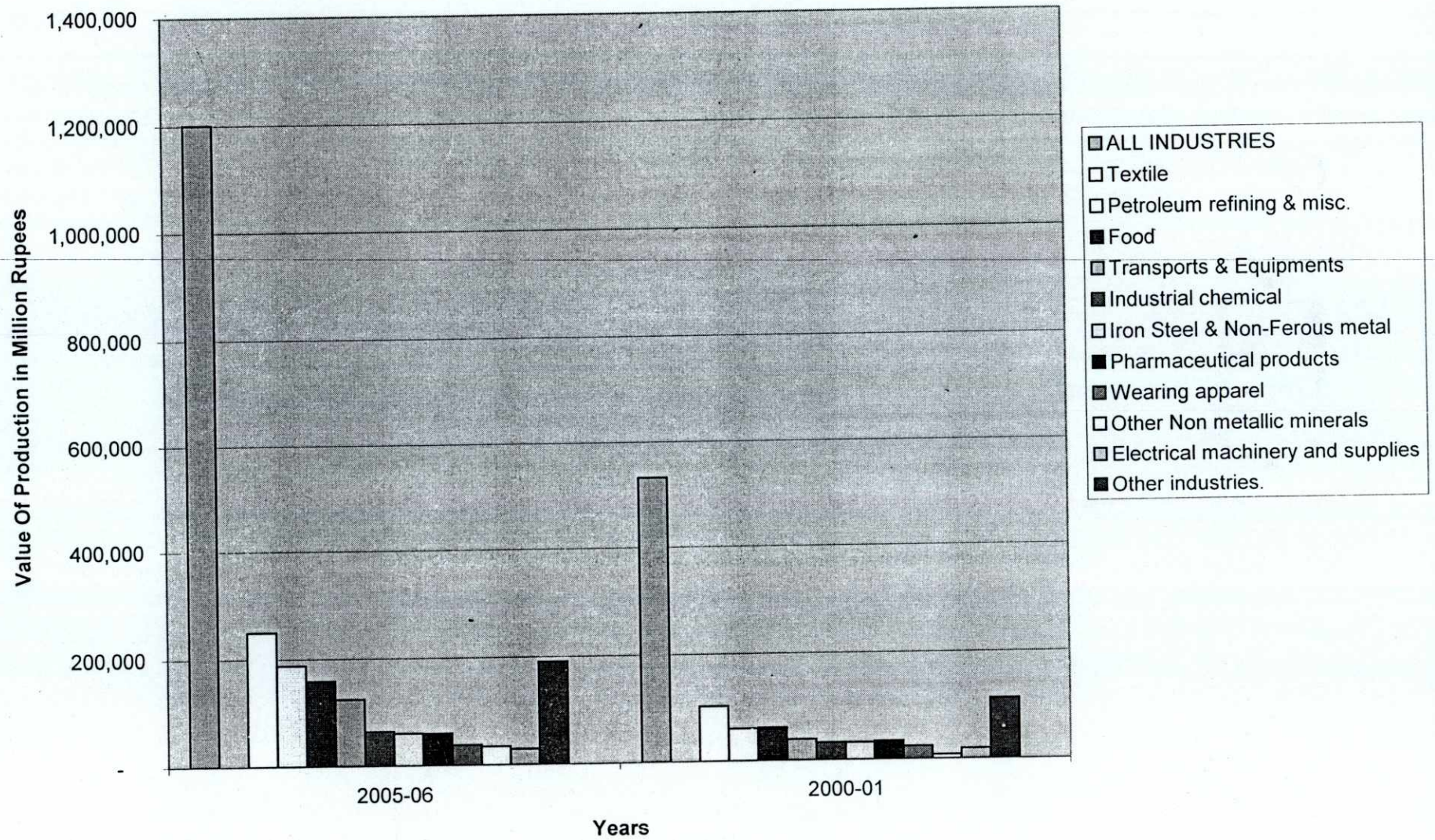
#### 4 VALUE OF PRODUCTION

Value of production during the year 2005-06 amounted to 1,200,402 million rupees showing annual an increase of 25.16% over 2000-01 which stood as 531665 million rupees. The highest value of production is shared by Manufacturing of Textiles followed by petroleum and Food Manufacturing . The comparative position of the first 10 leading industries in descending order is given in the following table:

Comparative Picture Of Value Of Production For The Years 2005-06 & 2000-01

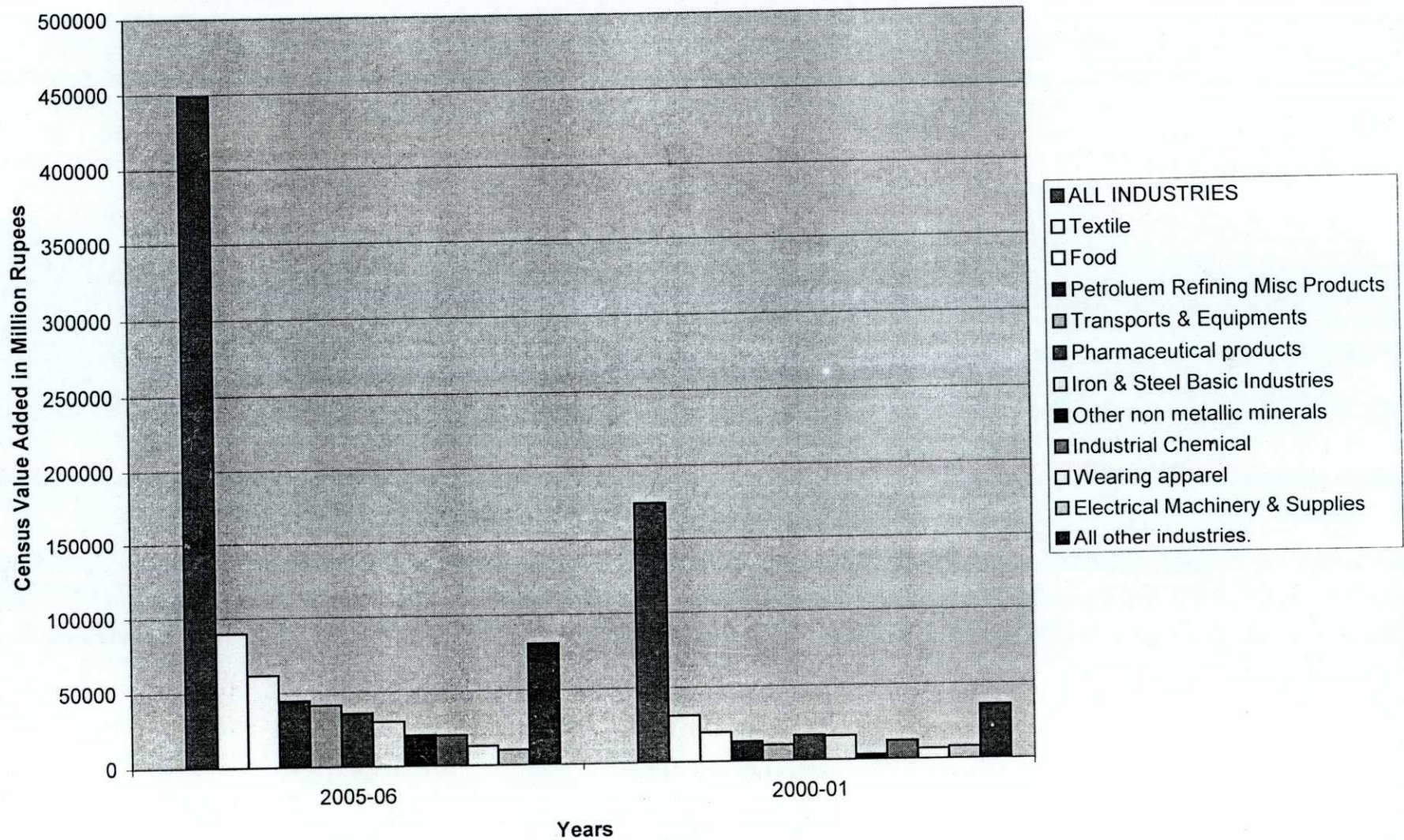


### 5. CENSUS VALUE ADDED

The total census value added during 2005-6 is 448,703 million rupees showing an increase of 31.37 per annum over 2000-01. Manufacture of textile topped the list by contributing 89.423 million rupees while food manufacturing and petroleum product ranked second and third respectively. 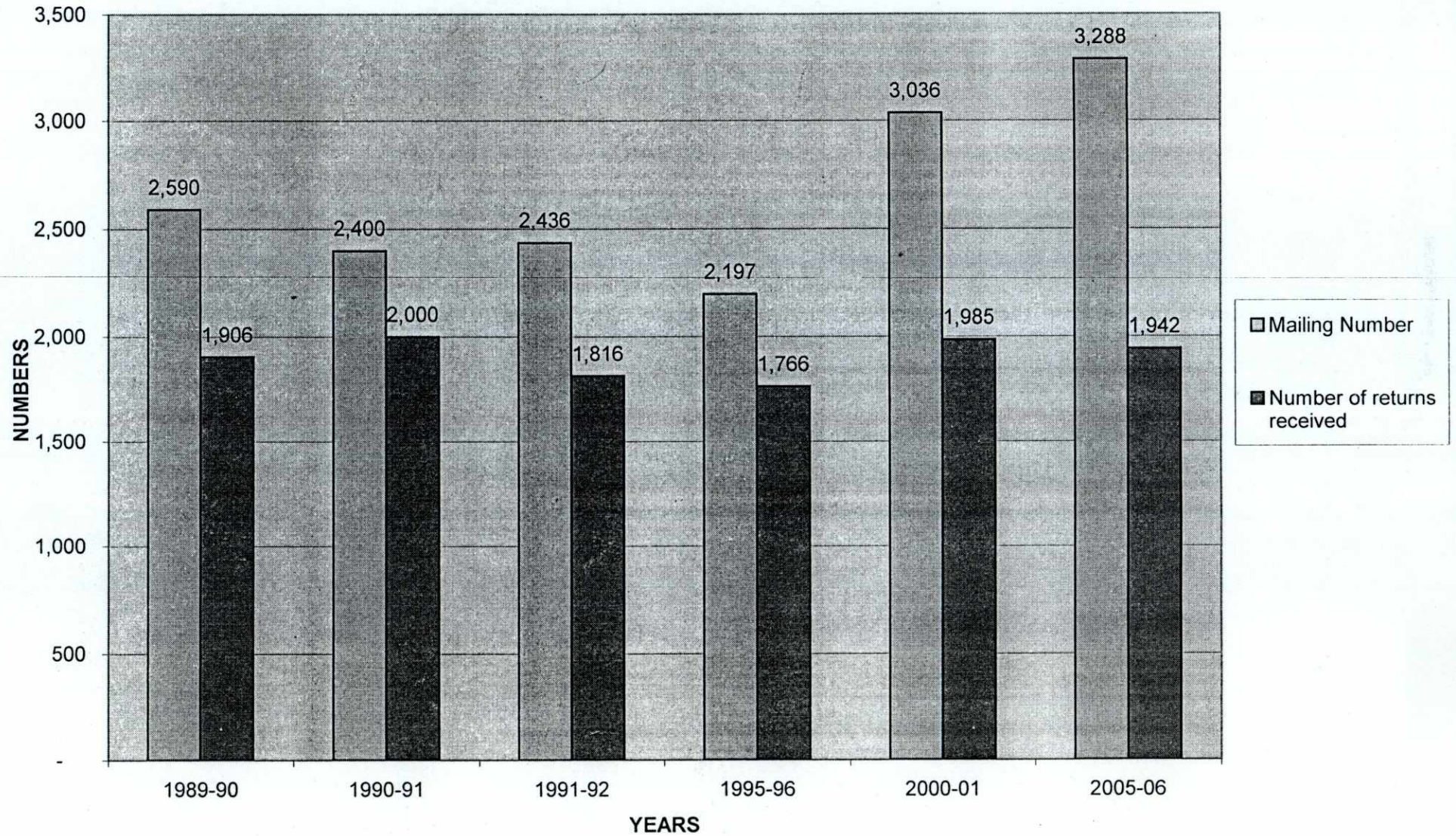
Comparative Picture Of Census Value Added For The Years 2005-06 & 2000-01
